We believe we have developed a solid plan that has been working for our county for the past couple of years. For this reason, there are no notable changes from our last submission. We were able to increase the number of poll workers at our busier locations and that worked well during the 2023 Primary. We plan to maintain this number and continually assess the need for additional personnel.

Early excused and no excuse voting takes place in the Clerk's office. This location is centrally located, and voters are becoming more familiar with this process. The voters of Lincoln County have been receptive to the eight vote centers, strategically placed around the county, in close proximity to our major highways. We have received positive feedback from voters as well as poll workers. We believe we have successfully meet the needs of the voters, while being fiscally responsible and responsive to the changes in the security landscape of the election process. The eight voting centers have allowed the Sheriff's office to retrieve the voting equipment immediately following the election and secure them back in the office by the end of the night.

For all these reasons, we respectfully request that approval be granted to the Lincoln County Voting Plan as submitted. Thank you for your time and consideration.


