State Board of Elections,

The McLean County Election plan for 2023 General Election is as follows:

Excused Absentee voting and No Excuse Absentee voting will be held in the McLean County Clerk's Office.

We will have all eight (8) precincts open at 5 voting locations. This is the same plan as last year and many years prior.

We do not consider them voting centers because, even though they are in the same room and share the same voting machines (scan and duo), the precincts are separate. Each precinct has a precinct specific EPB and poll workers.

Rumsey A101, Calhoun 1 C101, and Calhoun 2 D101 are at the same location, in the same room but Calhoun 1 & 2 share one (1) Verity Scan, Rumsey has one (1) Verity Scan. All three (3) precincts share one (1) Verity Duo.

Livermore 1 B101 and Livermore 2 C102 are at the same location, in the same room but share one (1) Verity Scan and one (1) Verity Duo.
