

1.) Why is this consolidation of these precincts desirable?

These 7 precincts have been located at this location since 2009. It provides good voter access, parking and space. Our county is rural and there are no other places that can provide the access, parking & space. I cannot find enough Election Officers to cover the precincts and there is only 1 space scanner. We are changing to a vote center for voter convenience.

2.) In what manner will Precinct Officers be assigned?

■ This location will be fully staffed with election officials

Each e-pollbook will have a Clerk, 4 Judges will be assisting with the ballot table and 4 judges will be assisting with the scanners and Touch writers and 4 Sheriff's to keep the lines moving. We are also planning on having a forms table for voters who need to fill out any forms, this will keep the lines moving also.

3.) How will the voting location be publicized to voters? How will the location be noted as a "Vote Center?"

This location has been used since 2009, housing 7 precincts. We will advertise in the local paper plus have signage.

4.) How will the voting location serve as a focal point to meet the needs of a diverse community?

No voter would travel more than 9 miles to their voting location. With this plan nothing would be any different than in years past except the use of less Verity Scanners, less Election Officers and the ability for the voter to cast their ballot at any location. We cannot find enough Election Officers that will work and we only have one spare Scanner. If more than one Scanner fails on Election day we have no more to replace it.

Our county is rural and there are no other places that can provide the access, parking & space. I cannot find enough Election Officers to cover the precincts and there is only 1 spare scanner. We are changing to a vote center for voter convenience.

Each e-pollbook will have a Clerk, 3 Judges will be assisting with the ballot table and 3 judges will be assisting with the scanners and Touch writers and 3 Sheriff's to keep the lines moving. We are also planning on having a forms table for voters who need to fill out any forms, this will keep the lines moving also.

3.) How will the voting location be publicized to voters? How will the location be noted as a "Vote Center?"

This location has been used since 2009, housing 5 precincts. We will advertise in the local paper plus have signage.

4.) How will the voting location serve as a focal point to meet the needs of a diverse community?

No voter would travel more than 8 miles to their voting location. With this plan nothing would be any different than in years past except the use of less Verity Scanners, less Election Officers and the ability for the voter to cast their ballot at any location. We cannot find enough Election Officers that will work and we only have one spare Scanner. If more than one Scanner fails on Election day we have no more to replace it.
