Attached is my Election Plan for approval for the 2024 Primary Election on May 21st, 2024. I am submitting this as new plan due to consolidating my former 11 precincts down to 3. However, I will be using the same setup and locations I used for the Primary and General Election in 2023.

This plan worked perfect for my county and the voters were very satisfied with the locations and setups at each location. Prior to 2023, we only had one vote center in our county for 11 precincts. When I became Clerk in 2023, I added two more Vote Centers to accommodate more voters and give the voters additional options of locations to vote on Election Day.

The three locations I use for Vote Centers are each located with one in each of our three precincts, giving voter's a voting location within their precinct and the option of utilizing one of the other voting locations if that fits into their daily schedule better. My goal as Clerk is to offer locations that are well known, comfortable and accessible for the voter. These are all locations my voters are familiar with and have become accustomed to being voting locations on Election Day.

If approved I will be using our General Butler State Park Conference Center, Public Library and Sanders Fire Department. The General Butler State Park Conference Center location tends to attract the majority of the voters, as they like the larger set up. In the 2023 Primary, 73.8% of voters on Election Day used this location, with 77.6% using it for the 2023 General Election. This location easily handled three fourths of the Election Day voters with no lines or waiting. I am often questioned by voters in my county why I added more than one Vote Center when I took office as Clerk but I wanted to add other options for voters on Election Day and felt we could benefit from the two additional locations.

Thank you for your review of my 2024 Primary Election Plan and I hope that you will see that it does and has worked very well for my county.
