The number of voting centers did not change we still have eight in Graves County, however in the South part of the county the Election Board did decide to move where one of the voting centers would be located. Cuba Church of Christ was one of the voting centers in the South part of the county we have used it for a couple of elections, and it has not been utilized as the Board thought it would be. Farmington Elementary School is also in the South part of the county and would be more convenient with it being a school, not only for the parking but for its location and its access ability. This still leaves three voting centers in the South of the county as stated and three voting centers in the North of the county with two voting centers being located centrally in the county.
