JOHNSON COUNTIES PLAN FOR THE PRIMARY ELECTION ON MAY 21, 2024 IS THE SAME BASICALLY THE SAME PLAN AS USED PREVIOUSLY. THE ONLY EXCEPTION IS THAT WE ARE ADDING A POLL CENTER AT THE JOHNSON COUNTY MIDDLE SCHOOL. THIS PLAN SPACES THE POLLING LOCATIONS OUT GEOGRAPHICALLY SO THAT VOTERS WILL BE COVERED IN ALL AREAS OF THE COUNTY. THE PLAN USING VOTE CENTERS HAS WORKED WELL IN PASSED ELECTIONS.

SCHOOLS AND GOVERNMENT BUILDINGS ARE GOOD CHOICES FOR MANY REASONS. THERE ARE NO COST TO THE FISCAL COURT FOR RENTAL OF THE FACILITY. THERE IS ACCESS THE HIGHSPEED INTERNET FOR THE USE OF POLL BOOKS. PARKING IS AMPLE AND VOTERS HAVE PROPER HANDICAP ACCESSIBILITY. THE POLLING LOCATIONS PROVIDE LARGER AREAS FOR THE VOTERS TO BE ABLE TO SOCIAL DISTANCE AND BE INSIDE OUT OF THE WEATHER.

HAVING VOTING CENTERS ARE WELL RECEIVED BY THE VOTERS AND THEY LIKE BEING ABLE TO GO TO ANY POLLING LOCATION AND CAST THEIR BALLOT. THIS CUTS DOWN ON THE NUMBER OF ELECTION OFFICERS.

HAVING LIMITED EARLY VOTING WAS A CHALLENGE. I MADE EVERY EFFORT TO INFORM VOTERS OF THE TIMES AND LOCATIONS FOR VOTERS TO BE ABLE TO TAKE ADVANTAGE OF EARLY VOTING. I HAVE HAD GREAT COOPERATION FROM THE LOCAL RADIO STATION, NEWSPAPER AND THE COUNTIES WEBSITES GETTING THE INFORMATION OUT TO VOTERS. THIS HELPS TO ELEVATE THE CROWDS ON ELECTION DAY.

THE VOTING EQUIPMENT WAS PURCHASED BY GRANTS FROM SBE. ES&S VOTING EQUIPMENT IS USED BY JOHNSON COUNTY AND WE ARE VERY PLEASED WITH THE PRODUCTS AND THE SERVICE PROVIDED BY THE COMPANY. THE EQUIPMENT IS VERY USER FRIENDLY TO THE ELECTION OFFICERS AND VOTERS ALIKE. HAVING A SECURE DROP BOX IN THE LOBBY OF THE CLERK'S OFFICE IS VERY HELPFUL AND EXTREMELY SECURE.

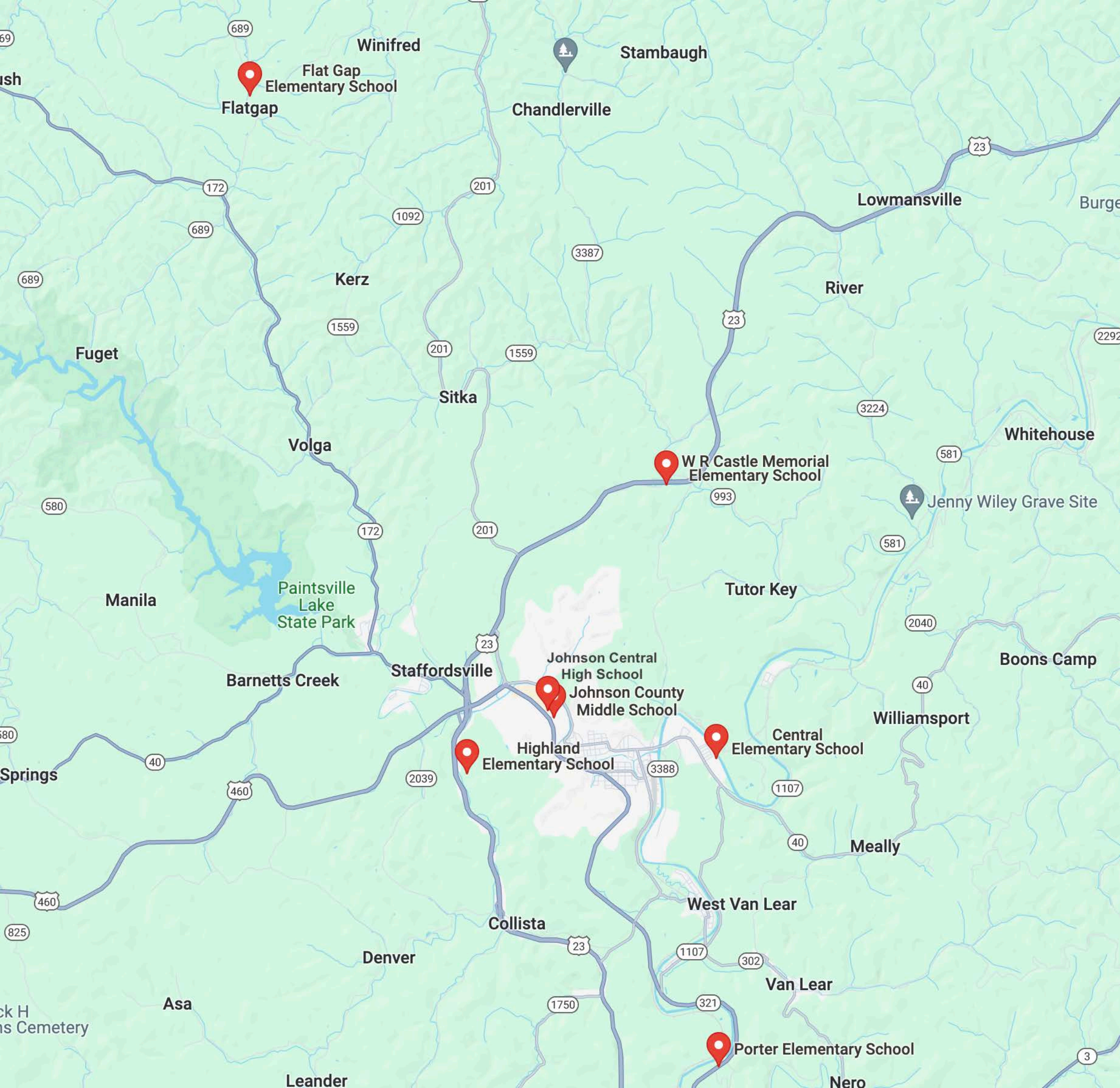
