1. Calloway County will have eight (8) Vote Centers consisting of:
  - a. CFSB Center (previously used)
  - b. North Elementary (previously used)
  - c. Southwest Elementary (previously used)
  - d. Elm Grove Baptist Church (previously used)
  - e. New Concord Church of Christ (previously used)
  - f. Hazel Baptist Church (previously used)
  - g. Kirksey Baptist Church (previously used)
  - h. Murray High School (NEW vote center)
    - i. Calloway County plans to add Murray High School as a vote center to give voters in the city another option within the city limits along with the CFSB Center. This will help accommodate voters in this area to alleviate longer wait times.
2. E-poll Station: Each location will utilize 2-4 check in stations
3. Voting Booths: Each location will have 10-20 voting stations
4. Ballot Scanners: Each location will have 2-3 scanners
5. ADA Machine: Each location will have 1 ADA voting machine
6. Precinct Officers: Each location will have 4-10 precinct officers
7. Early Voting (excused 6 day): Excused in person early voting will be held in the County Clerk's office.
8. Early Voting (no excuse 3 day): Early voting will be held at the County Judge Executive's office at 201 S 4<sup>th</sup> St Murray, KY 42071. This area was utilized in the 2020 and 2022 Election cycle and was well received.

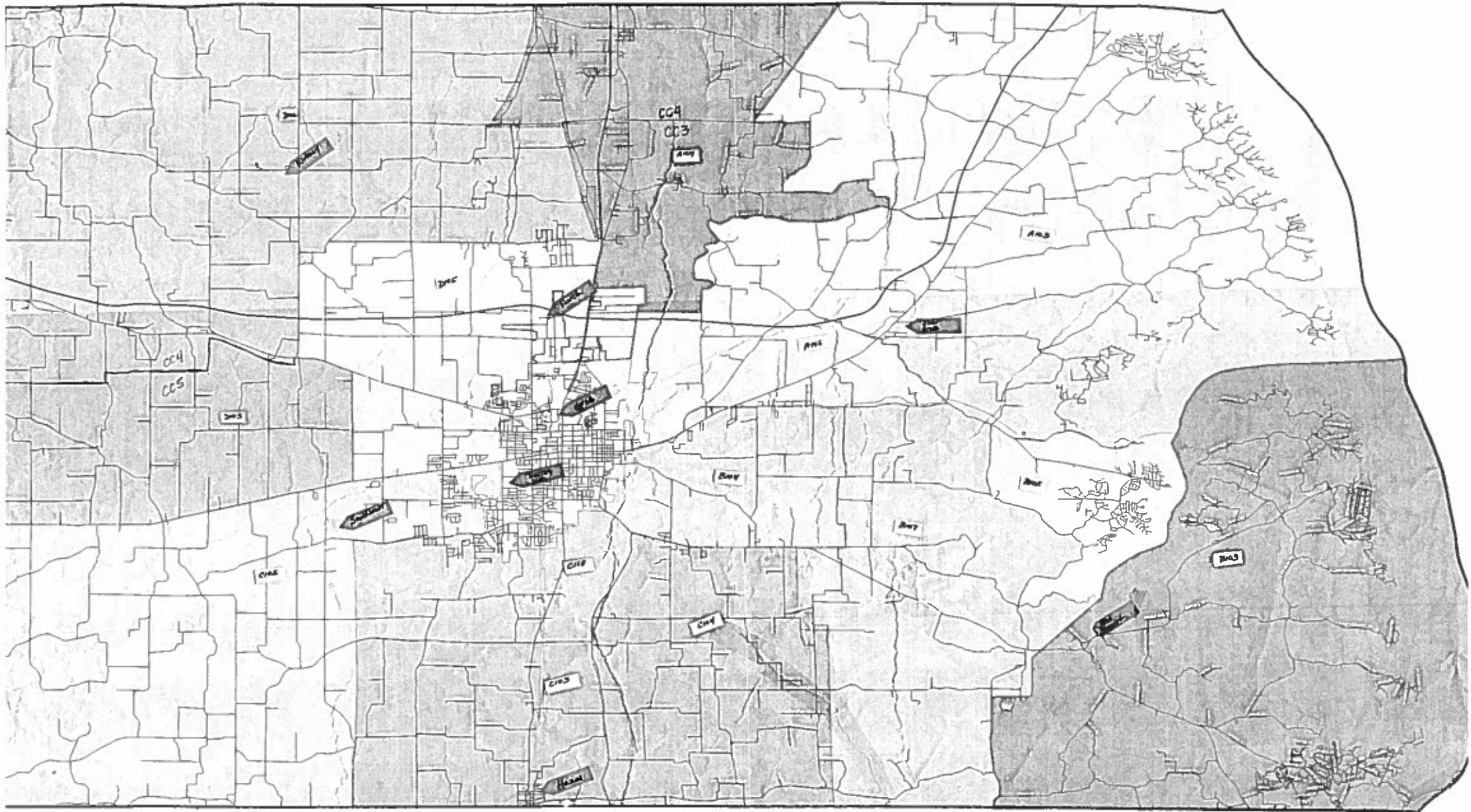
