3 31 KAR 4:170. Exceptions to prohibition on electioneering.

4 RELATES TO: KRS [~~117.015,~~] 117.235

5 STATUTORY AUTHORITY: KRS 117.015(1)(a), 117.235(3)(~~e~~[(d)])

6 CERTIFICATION STATEMENT: This is to certify that this administrative regulation  
7 complies with the requirements of 2025 RS HB6, Section 8.

8 NECESSITY, FUNCTION, AND CONFORMITY: KRS 117.015(1)(a) authorizes the State  
9 Board of Elections to promulgate administrative regulations necessary to properly carry  
10 out its duties. KRS 117.235(3)(~~e~~[(d)]) authorizes the board to establish exceptions to the  
11 prohibition on electioneering through administrative regulations. This administrative  
12 regulation establishes these exceptions.

13 Section 1. Definitions.

14 (1) "Bumper sticker" means a sticker that measures within fourteen (14) inches by  
15 five (5) inches for display on a vehicle bearing a printed message soliciting votes for or  
16 against any bona fide candidate or ballot question in a manner which expressly advocates  
17 the election or defeat of the candidate or expressly advocates the passage or defeat of  
18 the ballot question.

1 (2) "Electioneering" is defined by KRS 117.235(3)(ed).

2 (3) "Polling place" means a voting place established in accordance with the  
3 provisions of KRS 117.065 or KRS 117.066.

4 (4) "Voting room" means a room in which votes are polled as established in KRS  
5 117.235(1).

6 Section 2. Exceptions to Electioneering. Electioneering shall not include:

7 (1) A bumper sticker pursuant to KRS 117.235(3)(e)[~~(d)~~]; or

8 (2) A voter's use of a personal telecommunications device, computer, or other  
9 information technology system, in the voting room to record or transmit electronically an  
10 image of his or her own personal likeness and ballot, if the voter does not use the picture:

11 (a) To solicit signatures to a petition or solicit votes for or against any bona fide  
12 candidate or ballot question in a manner that expressly advocates the election or defeat  
13 of the candidate or expressly advocates the passage or defeat of the ballot question; and

14 (b) Within a distance of 100 feet of any entrance to a building in which a voting  
15 machine is located if that entrance is:

16 1. Unlocked; and

17 2. Used by voters on election day.
