Narrative Explanation of County Plan:

The Fayette County School Board met on Monday, September 28, to decide the school system COVID response for the next few months. The decision made on Monday opens the possibility of adding two elementary school locations to be used for both early voting and Election Day.

These two additional locations bring our total to 8 locations for both early voting and for Election Day. The two schools we chosen by their geographic location as the best supplement to our existing plan.

The schools are Wellington Elementary and Garrett Morgan Elementary.
