

The Fleming County Board of Elections voted on September 8, 2020 and approved of the following for the November 3 General Election:

Due to the Covid-19 pandemic, Fleming County will combine eighteen voting precincts to nine locations. Eight of the locations are spread out on the exterior of Fleming County in small communities. One location will be in Flemingsburg.

This will insure that the voters that want to vote on Election Day can do so in a less populated situation. Less lines and exposure to others.

We have adequate amount of accessible buildings, voting equipment, PPE, and polling workers to do this.

We will have early voting beginning on Tuesday October 13 in the Fleming County Clerk's Office, Monday-Friday from 8:00 AM-4:30 PM and on Saturday October 17, 24, & 31 from 8:00 AM-12:00 Noon.

Early voting will also be available Monday-Friday October 13-16 (8:00am-12:00pm) October 19-23 (1:00pm-5:00pm), October 26-30 (8:00am-12:00pm) in the Fleming County Activities Center
