RE: Metcalfe County Election Plan

Edmonton, KY is the county seat of Metcalfe County; it is located in the center of the county. Metcalfe County is a rural county and the town of Edmonton being the only place in the county to shop for groceries, get medicine, conduct banking and receive medical care. Edmonton is also where all the schools in the county are located. Metcalfe County has 7,923 registered voters.

The precinct A102 West Edmonton has been using the Edmonton Worship Center Gym to vote since 2017. This polling location is located in the center of town at 107 Baker St. It is 4 times larger in size than the community room we used in the primary election. This location is handicap accessible with parking and also has a covered walkway that is covered at the entrance. It also has a separate exit door, which will keep voters from coming in close contact with each other as they enter and exit the building.

We had a 26% turnout in the primary election with 1,916 people voting. We had no lines on Election Day at our smaller voting location used in the primary election. We secured 8 election officers for the primary election and we are planning on having 12-16 officers for the general election, it was very difficult to get 8 officers to work the primary election. This is the only location in the county I feel that is large enough to fulfill all our needs and follows social distancing recommendations. I feel this location will allow the voters choosing to vote in person on Election Day feel more comfortable doing so.
