**Narrative Explanation of County Plan:**

In order to reduce the potential of high vol./long lines on Election Day, Nov. 3, 2020 and provide better accessibility we have selected eight voting center facilities (8 large rooms) dispersed throughout the county.

These locations were selected based on the # of votes and proximity to nearby voting precincts. However, all voting locations are county wide voting centers and can accommodate all Scott Co voters. Note the following

calculations used as a basis for selection of the 8 locations & preparation for adequate # of PEO's and resources:

1. Northern Elem: A100 (1128), A102 (682), A106 (1574) & A112 (649)- total voters 4,033
2. Southern Elem: C114(1194), C118(1642), E124(841),F123 (671), F125(373), F131(600),G128(737),G130(912), G134(1230), & G138(6)-total voters 8,206
3. Anne Mason Elem: A104(550), A110(812), A114(176), A116(854) B101(1611), B109(640), E118(708), E120(548), E126(896) & E128(610)-total 7,405
4. Royal Spring Middle: D111(1403), D113 (2436), D119(1643) & D123(1191)- total voters 6,673
5. Stamping Ground Elem: B103 (950), B105 (763) & B111 (891)-total voters 2,604
6. Scott County Public Library: E122(863), F129 (876), G132 (1139) & G136(1162)-total voters 4,040
7. Eastern Elem: D115(839) & D121(815)-total voters 1, 654.
8. Western Elem: B113(868), C108 (1038), C110 (700), C112 (949), C116(1175), F117(1,473), F119(736), F121(884), & F127(1300)-total voters 9,123.
