**Narrative Explanation of County Plan:**

The Webster County Board of Elections met at 10am on Sept. 1st, 2020 and decided 4 voting supercenters would be best for the demographics of our county. Our county does not have 1 major city, but 4 smaller cities, and our cities are spread out geographically. The towns of Sebree, Clay, Dixon & Providence will all have 1 voting supercenter on Election Day. The rural areas of Onton, Slaughters, Poole & Wheatcroft we plan to offer 1 day in each area for mobile voting. Beginning Oct. 13th early voting will begin at the courthouse located at 25 US Hwy 41A S Dixon, KY. & will continue thru Nov. 2nd, Mond-Fri 8am-4pm, including the 3 Saturdays, where the hours will be 8am-noon. Post cards will be mailed to each Household informing registered voters of their options.
