Dear Mr. House,

As required, I am submitting all updated and no change information for Boone County for the 2023 General Election.

Ballot Drop box locations have not changed from the previously posted plan for Boone County. For the 2023 General Election, Boone County will have two drop boxes for absentee ballot return. In same locations as prior Election. One box located in our office at 2950 Washington St. Burlington KY 41005 in the Voter Registration Department and one box in the Florence Government Center main lobby located at 1800 Ewing Blvd. Florence KY 41042.

Regarding the six days of in person excused absentee voting, that will take place in our building in Burlington at 2950 Washington St. Burlington KY 41005 and there will be no other location.

Boone County made no changes to their in person no excuse voting plan. For the in Person no excuse Absentee Voting on Thursday November 2, 2023, Friday November 3,2023 and Saturday November 4, 2023 there will be one Vote Center in Boone County at the Boone County Extension Center at 1955 Burlington Pike Burlington KY 41005. The building also has an address of 1824 Patrick Dr. Burlington KY 41005, which will be the advertised location as this address is closest to the entry door to where voting will take place. This location is the only location for no excuse absentee voting, same as last Election.

I should note also that our Early Vote hours have not changed those will remain the same as the last Election. Those hours are as follows:
Thursday 9:00am-6:00pm

Friday 8:00am-5:00pm Saturday 7:00am-3:00pm

I have enclosed the newest version of form SBE 74 for all our previously consolidated locations as required. There also are five new consolidations we wish to make these precinct locations failedADA compliance. The five new consolidated locations are Hebron 1 (A108) and Hebron 3 (A114), Burlington 1 (A104) and Burlington 2 (A105), Richwood (B121) and Kensington (B134) (moving both to a new location together), Devon 1 (C102) and Florence 10 (C133), Devon 2 (C110) and Florence 6 (C129). Those written in bold are precincts that are being moved, the others were already at the location being used for bold precincts. Form SBE 74 has been attached for all these consolidations. We are also moving Walton 1 (B127) from its current location to a new location by itself due to ADA failure and facility will be selling the building and moving out of it in the middle of next year anyway. Walton 1 will be moved to the Walton Verona High School, this school had an ADA survey completed and submitted previously as we used it in 2020 as a vote center. New polling location for Richwood and Kensington will be Steeplechase Elementary. We performed a new ADA survey, which was emailed to VRS help desk as well as sent as an attached with this letter. A Polling Place Update form for all locations involving a move has been submitted to
