No excuse early voting will be held at The Showroom at 2405 Lebanon Rd in Danville. Excused early voting will take place in the Boyle County Courthouse at the Clerks Office.

#### **ELECTION DAY**

There will be a total of six voting centers spaced geographically for the North, South, East, West and central areas of the County.

- 1. Perryville Baptist Church
- 2. Parksville Baptist Church
- 3. Junction City Baptist Church
- 4. Inter County Coop
- 5. First Christian Church
- 6. The Showroom

On the maps, I have marked the six voting locations. VC1, VC2 and VC3 are in the County and VC4, VC5 and VC6 are in the city limits of Danville. VC2 and VC6 have been added as two additional voting centers for Election Day. VC6 will be used this election for both early and election day voting.
