Dear Kentucky State Board of Elections,

This letter is in regards to the Christian County Election Planning Report. I have attached all required SBE 74 sheets, along with relevant maps. There are a few changes to our election plan for future elections. The Christian County Board of Elections along with myself (3 to 1) agreed to reduce our voting centers from 16 to 13 and all in favor of adding an Early Voting site.

There were three (3) voting centers that didn't meet certain standards to be considered an adequate location. The locations don't have sufficient parking and are located in secluded areas. I must also mention, they have been poorly utilized by voters in the last two elections and are very close in proximity (less than a mile) from locations that are more favorable to voters. Please see attached data on ballots issued by voting center.

The past administration added several additional voting center sites without considering sufficient available parking and being easily accessible to ALL to voters. By adding more locations, it reduced the number of voting machines and Election Officers at our highly utilized voting centers, causing sufficient and unnecessary wait time for voters.

Now that we can track data of where voters tend to vote, we can use that information to provide the voters of Christian County with a quick and reliable voting experience. Please feel free to contact me with any additional questions you may have.


