The Franklin County Clerk's Office will be utilizing the same plan from the 2023 Primary Election for the upcoming 2023 General Election.

#### Absentee Mail-In

- Voters that qualify can request an absentee ballot at the following website: govote.ky.gov or call our office for assistance at 502-875-8704.
- On the 3<sup>rd</sup> floor, Fiscal Court, 315 W. Main Street, Absentee Mail in balloting will be processed by a committee with bi-partisan appointment from the Franklin County Board of Elections.
  - Tuesday October 24<sup>th</sup>, 2023 through Tuesday November 7<sup>th</sup>, 2023.
- The official ballot drop box will be located under surveillance at the Franklin County Clerk's Office in the lobby, 315 W. Main Street, starting on Monday September 25th, 2023 at 8:00 A.M. through Tuesday November 7<sup>th</sup>, 2023 until 6 P.M. (M-F).

#### Excused In-Person Absentee

- 6-Day Excused In-Person Absentee Voting will be located at the Franklin County Clerk's Office, 315 W. Main St. on the 2<sup>nd</sup> floor, handled by the Clerk's Election Staff and designees.
  - Wednesday October 25<sup>th</sup>, 2023 through Friday October 27th, 2023 and Monday October 30<sup>th</sup>, 2023 through Wednesday November 1<sup>st</sup>, 2023 (8:00 A.M.-4:30 P.M. each day).
