JOHNSON COUNTIES ELECTION PLAN FOR THE GENERAL ELECTION ON NOVEMBER 7, 2023 IS THE SAME AS THE 2023 PRIMARY ELECTION PLAN. THIS PLAN SPACES THE POLLING LOCATIONS OUT GEOGRAPHICALLY SO THAT VOTERS WILL BE COVERED IN ALL AREAS OF THE COUNTY. THE PLAN USING VOTE CENTERS HAS WORKED WELL IN PASSED ELECTIONS.

SCHOOLS AND GOVERNMENT BUILDINGS ARE GOOD CHOICES FOR MANY REASONS. THERE ARE NO COST TO THE FISCAL COURT FOR RENTAL OF THE FACILITY. THERE IS ACCESS TO HIGHSPEED INTERNET FOR THE USE OF POLL BOOKS. PARKING IS AMPLE AND VOTERS HAVE PROPER HANDICAP ACCESSIBILITY. THE POLLING LOCATIONS PROVIDE LARGER AREAS FOR THE VOTERS TO BE ABLE TO SOCIAL DISTANCE AND BE INSIDE OUT OF THE WEATHER.

HAVING VOTING CENTERS ARE WELL RECEIVED BY THE VOTERS AND THEY LIKE BEING ABLE TO GO TO ANY POLLING LOCATION AND CAST THEIR BALLOT. THIS CUTS DOWN ON THE NUMBER OF ELECITON OFFICERS. THE VOTING EQUIPMENT THAT WAS PURCHASED FOR THE JOHNSON COUNTY DOES NOT ALLOW FOR ALL 31 PRECINCTS AND THE PURCHASE OF ADDITIONAL EQUIPMENT HAS NOT BEEN APPROVED BY THE FISCAL COURT.

HAVING LIMITED EARLY VOTING WAS A CHALLENGE. I MADE EVERY EFFORT TO INFORM VOTERS OF THE TIMES AND LOCATIONS FOR VOTERS TO BE ABLE TO TAKE ADVANTAGE OF EARLY VOTING. I HAVE HAD GREAT COOPERATION FROM THE LOCAL RADIO STATION, NEWSPAPER AND THE COUNTIES WEBSITES GETTING THE INFORMATION OUT TO VOTERS. THIS HELPS TO ELEVATE THE CROWDS ON ELECTION DAY.
