- 1.) Why is this consolidation of these precincts desirable?
- This is the same plan used in the last election

The Middlesboro Community Center will be used as a 2nd location for absentee voting and early voting. This makes it more convenient for voters to have a choice in which location they chose to vote.

- 2.) In what manner will Precinct Officers be assigned?
- This location will be fully staffed with election officials

This location will be fully staffed for both absentee voting and early voting. There will be 4 election officers for absentee voting and 8 to 10 election officers for early voting. There will also be alternates available if more workers are needed.

3.) How will the voting location be publicized to voters? How will the location be noted as a "Vote Center?"

Postcards will be sent to every household on the dates and locations to vote as well as advertised in the newspaper.

4.) How will the voting location serve as a focal point to meet the needs of a diverse community?

This makes it more convenient for the voters in the Middlesboro community by giving them the chance to vote absentee or early without having to drive to the Pineville location.
