Dear Kentucky State Board of Elections,

This letter is in regards to the Christian County Election Planning Report for the November 2024 General Election. I have attached all required SBE 74 sheets, along with relevant maps. Our proposed election plan has a few minor changes from the May 2024 election plan that has been previously submitted from the last election.

Two of the changes are due to our public school system renaming certain schools we use as voting centers and one physical location change will offer more parking and a larger indoor area for our election officers and voters.

Proposed changes are as followed:

- Name change of previous Voting Center, Indian Hills Elementary to Inspire Early Learning Academy, no change to physical location.
- Name change of previous Voting Center, Hopkinsville Middle School to Indian Hills Elementary, no change to physical location.
- Physical location change of previous Voting Center, Crofton City Hall to Crofton Tornado Safe Room. The Safe Room building has been inspected and meets all KDC requirements. The distance between the previous location to new location is approximately 1.1 miles apart.







