

The Harlan County Election Board unanimously voted to continue to use the voting center model for the 2024 General Election. We have seen the success from elections since the 2023 primary and how beneficial it is to our community. Last election, we changed one voting center location to better accommodate voter's needs. Then we added three locations, one location that has a heavy voting presence, and two locations in hope to catch citizens entering/leaving Harlan at each end of the county. We currently have 21 voting centers which are spread throughout Harlan County providing them more opportunities to cast their vote.

Excused Absentee Voting will be held at the Harlan County Courthouse, 205 E Central Street, Harlan KY 40831 from October 23, 24, 25, 28, 29 and 30th from 8:30 AM to 4:30 PM.

No Excuse Absentee Voting will be held at the Harlan Civic Center, 201 S Main Street, Harlan KY 40831 from October 31, November 1, 2, 2024, from 8:30 AM to 4:30 PM. This location is centrally located and very accessible for our voters.

Drop Box will be located inside the Harlan County Courthouse, 205 E Central Street, Harlan KY 40831. This convenient location has been used in the past and is very easy to locate.

A few important factors to keep in mind is that although we have 32 precincts, multiple precincts shared the same building. We also had connectivity at all voting centers and we anticipate its continued availability. Our community loves the voting center model and we have citizens often comment on how much easier and convenient it is for them.
