The 2024 General Election Plan for Henderson County is as follows:

- 1. Henderson County has 2 drop boxes for Absentee Voters. One is located outside of our office doors under 24/7 video surveillance and our second one is located outside the building beside the steps as you enter the Courthouse. It is also under 24/7 video surveillance.
- 2. Our 6-day Excused In-Person Absentee Voting will take place in our office at 20 N. Main Street, Henderson, KY 42420 during our regular business hours of 8:00am-4:30pm, Monday-Thursday and from 8:00am-6:00pm on Friday.
- 3. Our 3-day No-Excuse In-Person Absentee Voting will take place at the Chase Fulcher Archery Center, 377 Garden Mile Rd, Henderson, Ky 42420. We will be open on Thursday, Oct 31, 2024-Friday, Nov 1, 2024 from 8:00am-5:00pm and Saturday, Nov 2, 2024, from 8:00am-4:00pm.
