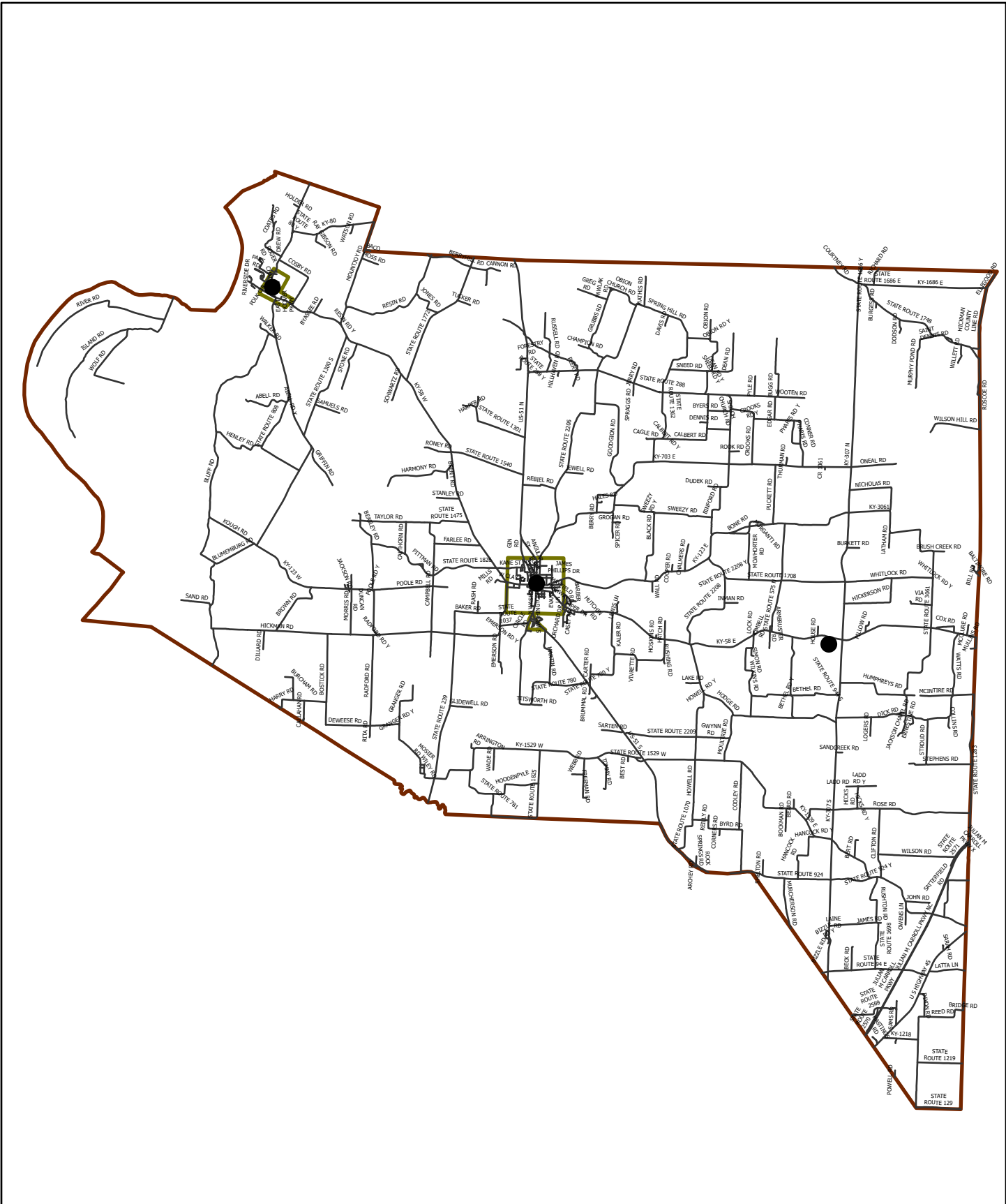

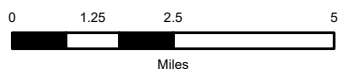
- Roads
