Jefferson County's election plan for the 2024 General will be slightly different than the 2024 Primary Election plan. In-person excused voting will be conducted at the Crowne Plaza Hotel located at 830 Phillips Lane, 40209. This is to accommodate the larger number of voters during the in-person excused voting. Jefferson County has contracts with seventeen locations for early voting currently. We intend to add more locations to accommodate an increase of early voting voters. Attached are the SBE 74 forms for each of the locations of in-person, no-excuse absentee voting. Jefferson County intends to open all polling locations for all precincts on Election Day. Pursuant to KRS 117.006, I have attached SBE 74 forms for large precincts sharing election officers with small precincts on Election Day.

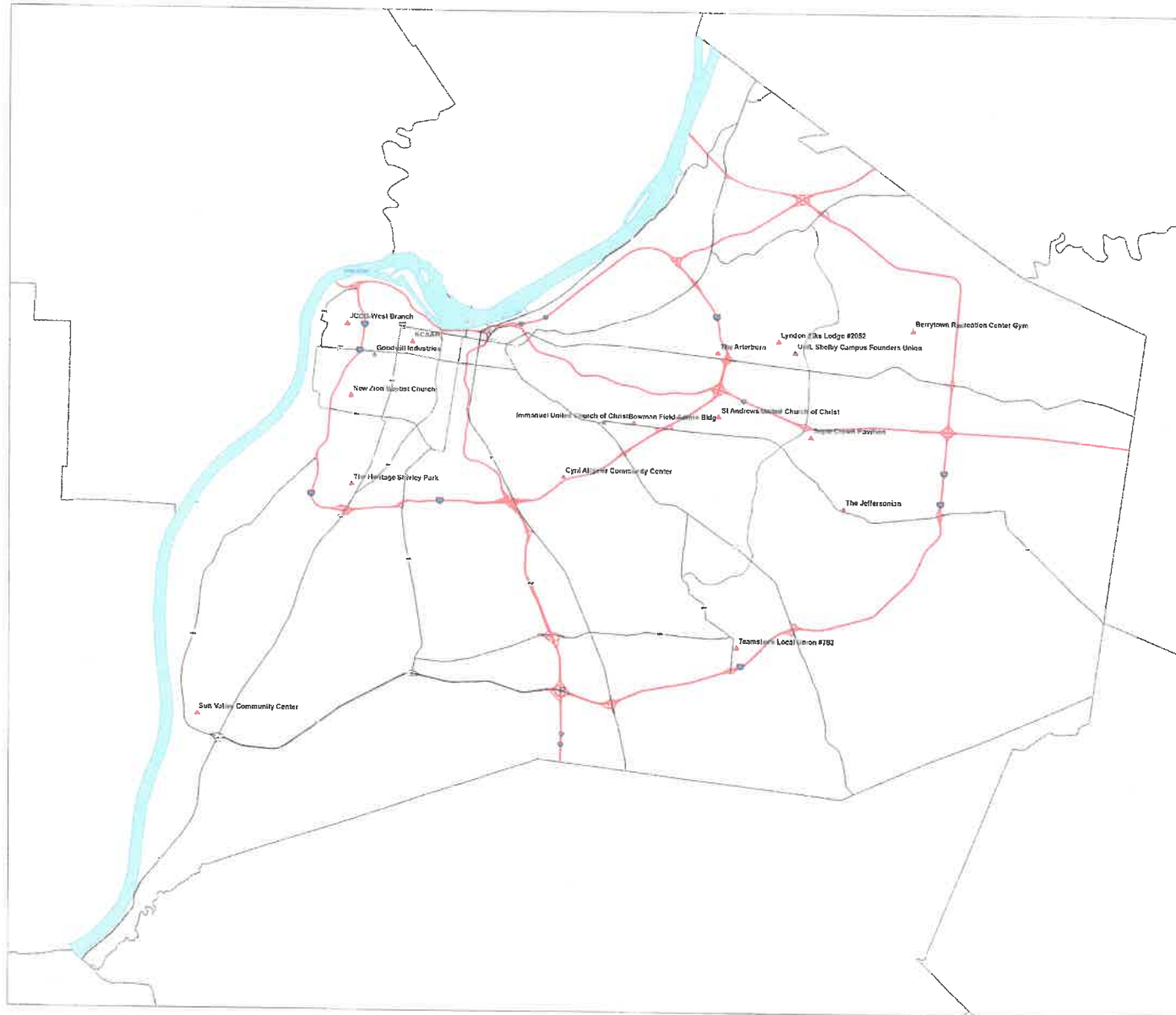


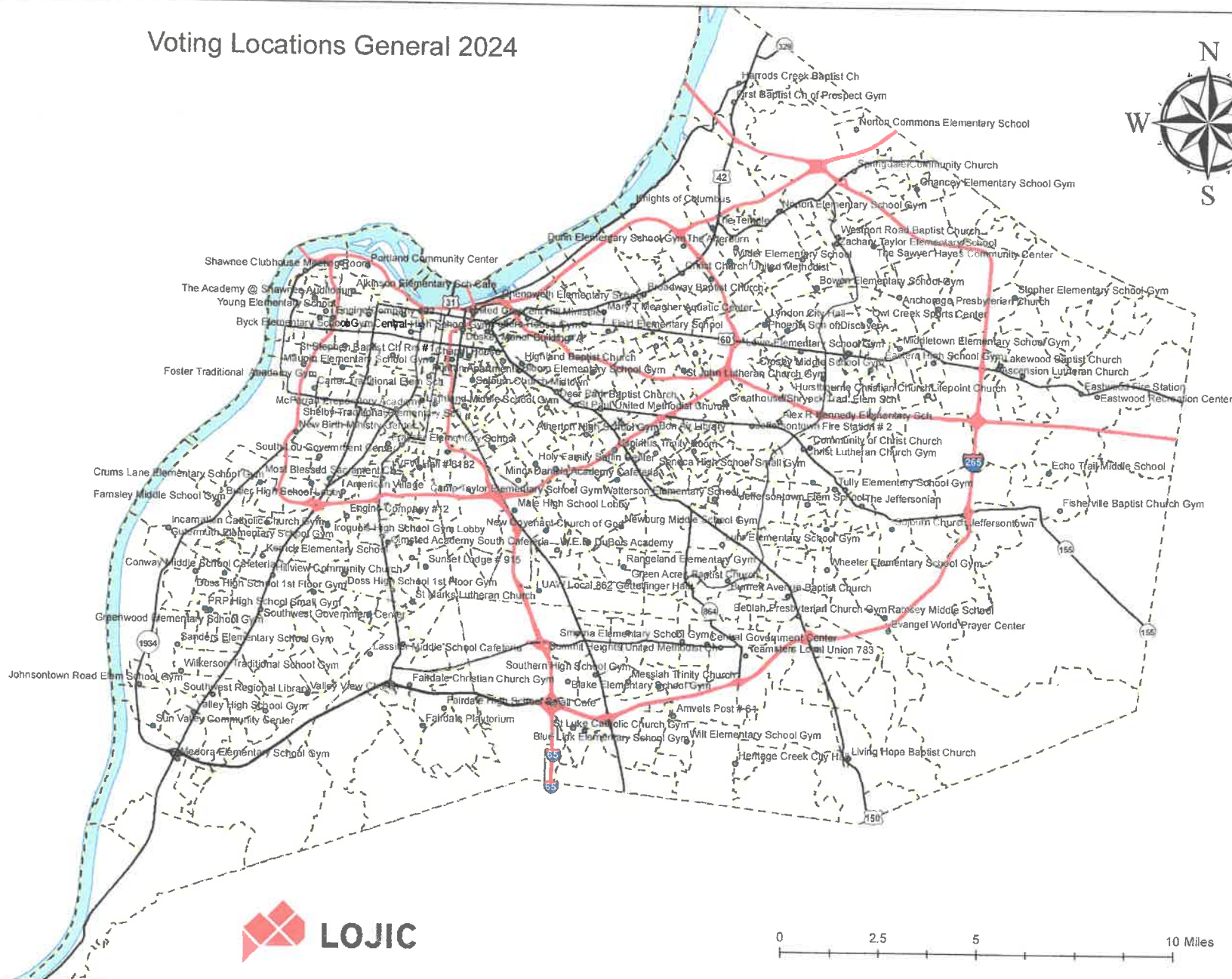
