The Nelson County Board of Elections has voted to change our Election Plan for the upcoming 2024 General Election. The following will explain the changes:

- 1. We have elected to consolidate from 12 locations used in the Primary to 8 locations. This was decided to make better use of our equipment and Precinct Officers.
- 2. Each of the 8 locations will be a vote center. We have been using consolidated Precincts in the past Elections.
- 4 locations will either be in Bardstown (our largest city and county seat), or within 2
  miles of the corporate limits. The other 4 will be in outlying area of Nelson County. 1 in
  each area of population in Nelson County (Bloomfield, Coxs Creek, New Haven and
  Boston)
- 4. Each location will have 2 Verity Scans, 1 Verity Duo, at least 2 Verity Prints and 4 Poll Books. Boston is the only exception; it will only have 3 Poll Books.
- 5. Every voting location was used in previous Elections except Bardstown Elementary School. This is a newly built facility that just opened in late 2023.
- 6. We anticipate staffing each location with a minimum of 6 Precinct Officers. Ideally, 7-8 per location, depending on availability of Precinct officers. Each location will also have a Deputy from the Clerk's Office there to act as Point person for Election Day.
- 7. We are planning to send postcards to every registered voter household in Nelson County to make them aware of the changes.
- 8. We are moving our Excused In-Person Voting out of our office to the Civic Center and our No Excuse In-person Voting will be at our Public Library. We have used our library since 2020, but moving our Excused Voting will be new for the 2024 General Election. A sheet for each location is included in our plan.


