Shelby County will be using the same plan for the 2024 General Election as was utilized for the 2024 Primary Election.

The location for Shelby County's Drop Boxes (2 total) is the Shelby County Courthouse Annex, 501 Washington Street, Shelbyville, KY 40065. One box is located just outside our front door and the other is inside in the lobby. Both boxes are under 24-hour camera recorded surveillance by Sonitrol.

Shelby County's 6-Day Excused In-Person Absentee Voting will be conducted at the Shelby County Courthouse Annex, 501 Washington Street, Shelbyville, KY 40065 during regular office hours.

Shelby County's 3-Day No-Excuse In-Person Absentee Voting will be conducted at the Shelbyville Welcome and Conference Center located at 219 7<sup>th</sup> Street, Shelbyville, KY 40065. The dates and times are as follows:

- October 31<sup>st</sup> (Thursday) and November 1<sup>st</sup> (Friday) from 10:00 am to 6:00 pm
- November 2<sup>nd</sup> (Saturday) from 8:00 am to 4:00 pm
