4.) How will the voting location serve as a focal point to meet the needs of a diverse community?

This proposed consolidation of precincts is the plan Woodford County utilized for the elections in 2020, 2022, 2023, and the Primary of 2024. The entire process of having a voting center at Falling Springs Recreation Center was extremely well-received by the Woodford County voters. This is due to the efficiency and speed of their voting experience because of there being absolutely no problems with long lines due to having 15 check-in stations and 138 voting booths. The replication of the clearly defined, successful plan that was used in previous elections at the Falling Springs Voting Center, which is centrally located in the middle of the county, is respectfully requested for consideration.

The Woodford County Board of Elections received enormous positive feedback from voters on Election Day (while voting at Falling Springs Recreation Center), and weeks after the election. Several aspects of voting at this voting center have been increased to include:

- 3 basketball courts with 12 check-in stations, equipped with 120 voting booths;
- a multi-purpose room close to the front entrance with 2 check-in stations, equipped with 10 voting booths, and;
- a front door check-in station that has a Verity Duo machine for the safe, accessibility for voters with mobility issues, equipped with 8 voting booths that accommodate a wheelchair.

This plan provides a total of 15 check-in stations and 138 voting booths. Based on previous elections, having 15 clerks available to sign in voters on the E-Poll Book produces a 45 second to 1 minute check-in time. Any delay to move a voter through the check-in process to receive their ballot and cast their vote would be minimal to none. As in the past elections, a command center will be stationed at this voting center that will have six (6) deputy county clerk's there to accommodate any of the voting needs that may arise such as change of addresses, validating a correct address to be assured that voter is receiving the correct ballot, and filling out all other forms necessary for the administration of this election.

The size of the parking lot at this voting center will accommodate approximately 350 parking spaces for the largest number of participants, by design, due to the many activities, i.e., sporting events, theater attendance, etc. that are held there daily.

As in previous elections, there will be golfcarts available on the lot to pick up voters from their cars and deliver them to the door of the voting center **and back to their car after they have voted**. Additionally, we have a wheelchair ready and accessible for any voter with mobility issues who needs assistance getting from the curbside handicap parking space to the front door.

2. In what manner will Precinct Officers be assigned?

With 15 check-in stations available, there will be a Clerk, a Democratic Judge, and a Republican Judge at each station. There is no need to have a Sheriff assigned to each station; however, there will be one Sheriff assigned to oversee the needs of each basketball court and the multi-purpose room, and 2 Sheriff's at the front door to accommodate the needs of any voter who has mobility issues. By using this order of assignment, there would be a reduction of 9 Sheriffs assigned as Precinct Election Officers, creating a savings to the fiscal court.


3. How will the voting location be publicized to voters? How will the location be noted as a "Vote Center?"

First and foremost, all Precinct Election Officers who witnessed the positive voting experience at the "Falling Springs Voting Center" while serving during the 2020, 2022, 2023 and 2024 Primary Election is the best form of publicity. They would not only be announcing the location, but they would be able to express as a first-hand witness how the voting process was efficient and fast at Falling Springs and how the parking was not an issue due to having a golfcart move voters to and from their parking space to the front door. Of course, the normal forms of advertising would be used such as our local newspaper, social media, a text messaging service, and signage. This location would be noted as the "Falling Springs Voting Center."

4. How will the voting location serve as a focal point to meet the needs of a diverse community??

The Falling Springs Recreation Center is the focal point of our entire community. If you are familiar with the center and the County Park here in Woodford County, you know this facility is used by all ages with the theater, pools, basketball courts, fitness center, numerous ball fields, soccer stadium/football stadium, fairgrounds, etc.

The location of this center, which serves as the pivotal, essential hub of our community, is located in the center of the county as evidenced by the map attached. As shown on Attachment A, a Voting Center at the Falling Springs Recreation Center is more than reasonably accessible to all voters and can allow 138 voters to vote at one time.






