Below explains the separation between precincts for Greenup County's map & machines used at each precinct:

Greenup County has fifteen precincts spread across our county that is conveniently located at fire departments, church fellowship halls, and at each school district. We also have one vote center located at the Greenup County Courthouse. Each precinct is handicap accessible, has sufficient parking, and spacious voting areas to accommodate the voters.

In the primary of 2022, our county election board made the decision to combine precincts due to the lack of poll workers. The decision was made cautiously to combine those precincts that were located within just a few miles of each other, so the voters are still voting close to their home. The plan was approved and we have continued to use this plan for the last four elections. There have been no complaints about the adjustments to our election plan and the voting lines have continued to move quickly and efficiently with the help of our poll workers.

Greenup County went from 29 voting locations to 16 including the vote center. We have 6 single precincts which is located in our more rural locations, 4 locations with two precincts, 5 locations with three precincts, and one vote center for all voters.

Each precinct location that is a single precinct has one verity scan machine and one verity duo. The precinct locations that have one or more precincts has two verity scan machines and one verity duo.

I have attached a map to help you better understand the separation in some precincts. Our precinct area that shows more separation on the map is single precincts which is located in more of our rural area of the county. We have smaller number of registered voters at these locations ranging from 700 to 1,100 voters. However, if you look at the map where we have most precincts located this is where the majority of our population is, including our cities. These precincts range from 1,400 voters to 3,800 registered voters.

We have used this plan for four elections, including our county election with a very large voter turnout. All elections have gone smoothly without any complaints
