To Whom It May Concern:

Here in the Jessamine County Clerk's Office, we are requesting to have 10 Voting Centers for the 2024 Primary Election. We increased the number of voting centers last year from 8 to 10. During this upcoming Primary we have added an extra check- in station to the facilities that can handle more. Adding those extra check – ins also mean we must find more election workers which hopefully is not a problem. Adding an extra Check-In will allow for more voters at one time to check in through the Poll Pad and have their ballot printed on demand. Our Check-In Station consists of the Poll Pad with an Election Worker process that portion of the check-in and then the Verity Print right next to the Poll Pad with an Election Worker processing the on-demand ballot print. So, in essence the voter doesn't leave our check-in station until they have their ballot in hand to go mark their selection in a privacy booth. Don't hesitate to reach out if you have any questions concerning our plan for the 2024 Primary.
