Lincoln County has one drop box located in the foyer of the Lincoln County Clerk's Office. It is visible to staff during open hours and the area is locked during closed hours.

EARLY VOTING:

Early excused and no-excuse voting takes place in the County Clerk's office. Voter's have been coming to our office for absentee voting many years and are familiar with the location.

ELECTION DAY:

We are asking to utilize the same 8 voting centers we have in the past and which are shown on our map attached hereto. Voters are notified via radio, newspaper, website and Facebook of locations, dates and times. The sheriff's office and road department assist with securely transporting equipment to and from all 8 locations.
