The McCracken County Board of Elections determined that 2 or more established precincts, with the same ballot face, could be combined and vote at the same assigned location as the previous election. We have taken 28 precincts down to 12 combined. We still have 26 precinct specific precincts that will remain the same as the previous election at the same voting location. Due to the restructure, we have added 3 additional precincts, 2 being ghost precincts A125 COMMERCIAL, A126 TOWER with no voters and 1 precinct B128 HENDRON #1 EXTENSION, being an extension from a previous precinct HENDRON #1.
