The McLean County Election plan for 2024 is as follows:

Excused Absentee voting and No Excuse Absentee voting will be held in the McLean County Clerk's Office.

We will have all eight (8) precincts open at 5 voting locations.

This is the same plan used in 2023 Primary and General Elections.

Rumsey A101, Calhoun 1 C101 and Calhoun 2 D101 are at the same location, in the same room but Calhoun 1 & 2 share one (1) Verity Scan, Rumsey has one (1) Verity Scan. All three (3) precincts share one (1) Verity Duo.

Livermore 1 B101 and Livermore 2 C102 are at the same location, in the same room but share one (1) Verity Scan and one (1) Verity Duo.

We have no voting centers.
