Precinct A101 (Muldraugh) – this precinct is in an area that is not centrally located in the county. Most of this precinct is the City of Muldraugh in which the polling place is located. We are leaving this precinct to vote in their normal location at Muldraugh City Hall. This Precinct will be the only precinct voting at this location.

We will have a consolidated voting location at Ekron Elementary School. Voting at this school will be E101, E102 and F105. This is a smaller location and was a consolidated voting location in the 2023 Election.

We will have a consolidated voting location at Payneville Elementary. Voting at this school will be F101, F102 and F103. This is a smaller location and was a consolidated voting location in the 2023 Election.

We will have County-Wide Voting Center locations at 3 schools. These areas are convenient in many aspects to serve all citizens of the County and can accommodate large crowds.
