Shelby County will be using the same plan for the 2024 Primary Election as was utilized for the 2023 elections with one exception. Since this is a presidential election year, we anticipate higher turnout, especially in November, so we are moving the 3-Day Early Voting to a larger facility with more parking. More specifics on this change are listed below in **Bold** and SBE 74 attached.

The location for Shelby County's Drop Boxes (2 total) is the Shelby County Courthouse Annex, 501 Washington Street, Shelbyville, KY 40065. One box is located just outside our front door and the other is inside in the lobby. Both boxes are under 24-hour camera recorded surveillance by Sonitrol.

Shelby County's 6-Day Excused In-Person Absentee Voting will be conducted at the Shelby County Courthouse Annex, 501 Washington Street, Shelbyville, KY 40065 during regular office hours.

Shelby County's 3-Day No-Excuse In-Person Absentee Voting will be conducted at the Shelbyville Welcome and Conference Center located at 219 7th Street, Shelbyville, KY 40065. The dates and times are as follows:

- May 16th (Thursday) and May 17th (Friday) from 10:00 am to 6:00 pm
- May 18th (Saturday) from 8:00 am to 4:00 pm
