

This location will be fully staffed with election officials





Post cards (mailed to all voters in these precincts), newspaper, online news paper, signs posted at old precincts directing to new location, larger sign posted at end of road to new location


**4.) How will the voting location serve as a focal point to meet the needs of a diverse community?**
