

To the Kentucky State Board of Elections:

Please find enclosed the completed SBE 74 forms for the 2026 Primary and General Elections. The vote center locations listed below are the new amended locations that the Bullitt County Board of Elections has determined to now be used for Early and Election Day voting. We believe they are suitable to be used as voter centers.

The school facilities have served voters well, received positive feedback, and remain the most suitable taxpayer-funded buildings available in Bullitt County. They are modern, spacious, ADA-accessible, and provide ample parking to accommodate Early voting and Election Day traffic.

Bullitt County uses a vote-center model that allows voters to cast a ballot at any location in the county. For Early voting, Paroquet Springs Conference Center in Shepherdsville will serve as the central site, providing convenient access especially for voters in the central, western, and southern areas. Additional locations are Jesse Schott Building in the north and Mt. Washington First Baptist Church and Pleasant Grove Baptist Church in the east ensuring countywide accessibility. This model is new and the BC Board of Elections believes it will be adequate for our voters.

Election Day voting will utilize the early-voting locations listed above along with the following additional sites: Shepherdsville Elementary, Bullitt Central High School, Bullitt East High School, North Bullitt High School, Overdale Elementary, Nichols Elementary, and Lebanon Junction Elementary.

We note one uncertainty: the ongoing reconstruction of the bridge connecting Hwy 44E and Hwy 61N. This bridge carries more than 10,000 vehicles daily, and its closure may influence voter travel patterns and complicate simultaneous emergency machine responses in the north and east ends of the county.

In prior years, the Kentucky State Board of Elections directed us to increase voting capacity. My Board of Elections and I have done so, and the amended proposed locations continue to meet the needs of our citizens. We also anticipate strong turnout in 2026 due to several contested local races and the U.S. Senate race. Reducing or relocating voting sites was not originally the plan of the BC Board of Elections, but the plan has been changed due to input from various groups.

We believe this plan is suitable and I ask for the approval of the KY SBE Board.




