The 2026 Election Plan submitted on behalf of Crittenden County Board of Elections is essentially the same as all elections since November 2023, except for a reduction in extra precinct election officers at each site over the 2024 presidential election. We will, however, continue to employ a coordinator at the countywide voting center on election days to better ensure voter and poll workers forms are completed properly and all questions can be answered as efficiently as possible.

Once again, Crittenden County Office Complex will serve as home for all Early Voting and as the countywide Voting Center. The building offers full ADA accessibility, more than adequate parking, a spacious voting room, a kitchenette for precinct election officers and public restrooms. The voting room also lies across the hall from Crittenden County Clerk's Office and Board of Elections meeting room, which is convenient for addressing any issues that may arise.

Marion Baptist Church, which served as a voting center in the past, will also be held in reserve in the event a replacement location is needed.

Precinct-level voting will continue to be hosted at four traditional rural locations – Shady Grove Volunteer Fire Department and Deer Creek, Mexico and Repton Baptist churches. All but Mexico Baptist Church will host only their home precinct, while that location will serve two precincts in southern Crittenden County.

This plan has been met with no issues, even with a near-record turnout in last year's presidential election. Additionally, all five sites have updated U.S. Department of Justice ADA surveys with temporary measures in place to address a handful of minor issues.

This plan should suffice for both the May primary and November general election.
