2026 Absentee Mail-In Ballot Procedures

Online Portal opens 4/4 and closes 5/5

We can mail out absentee until 5/6

Absentee mail in ballot processing committee approval by CBOE.

Chief Deputy Tonya Gordon, Deputy Clerks Sabra Wooten, Lilly Effron, Shane Culbertson Part-time worker, Karen Pearl and Stephane Bebe

Approved committee will be authorized to scan, open and process mail-in absentee ballots on behalf of the County Board members. Complete party parity will be maintained throughout every process.

1. Ballot Processing Committee will meet daily to scan/process absentee ballots at 9:30 A.M. Additional dates and times will be permitted if necessary.
2. Time stamp absentee ballots received in the mail by office staff, place them in the ballot box in the lobby of the County Clerk's Office. Ballots walked in by the public are to be placed by the individual dropping it off in the ballot box in the lobby as well. Ballots will be collected from the drop box by Sabra Wooten and Lilly Effron (or a representative from the processing committee for each party) daily at 4:00 P.M. The ballots dropped off by the public are to be timestamped immediately after collection.
3. Count and log the number of ballots received by mail. Count and log the ballots dropped off by the public. This log will be maintained on the first floor.
4. The absentee ballots will be taken to the third-floor conference room and will be locked in the metal lock box. The total amount of incoming ballots retrieved from the drop box and USPS will be logged on the "unscanned incoming ballot log" located on the "unscanned" locked ballot box.

The log will identify the date the ballots were received, the quantity of ballots received that day, both deputy clerk's initials, the date the ballots were removed, quantity removed, and deputy clerk's initials.

5. Ballot Committee to meet and pull unscanned ballots out of locked box (keys in secure locked box) starting May 6th (machine certification April 21st). Prepare a batch control sheet, cut the outer envelope open, then proceed to the scanning/signature cure process.
6. Each batch of outer envelope opened ballots will be scanned with the hand scanner one at a time with parity maintained throughout the entire process. The outer envelope will be scanned first and compared to the signature on file in VRS, then the signature on the yellow envelope will also be compared to ensure that the signatures match. **YELLOW ENVELOPES WILL NOT BE OPENED AND WILL STAY INTACT.** (Log beginning count, rejected, and final count under signature verification on the Ballot Envelope Batch Control Sheet).
7. Once scanning and the comparison of signatures is completed, the yellow envelopes will be cut open and the ballots removed.
8. All outer envelopes, yellow envelopes, and ballots will need to be counted separately to make sure there are a correct amount of each (example: 25 outer, 25 yellow, 25 ballots). (Log the verification count, envelope error, and final count on the ballot preparation portion of the Ballot Envelope Batch Control Sheet).
9. Ballots will be scanned into the verity scanner by party parity committee members. (Log the preparation count, removed for duplication, and final count under the ballot scanning portion of the Ballot Envelope Batch

Control Sheet. Also, write the Starting Count # on the verity scanner and the Total Count).

10. The opened envelopes will be rubber banded together with a filled in, completed batch report on top. Committee members will place those inside another box after scanning is completed and saved for retention.


