Early Voting Procedure

Fulton County will be providing 3 days of early voting on the Thursday, Friday and Saturday, immediately preceding the 2026 Primary & General Election. The plan is as follows:

Thursday early voting will be taking place at the Fulton City Pontotoc Building, located at 100 W Stateline Street, Fulton, KY 42041.

Friday early voting will be taking place at the Fulton County Office Building located at 2216 Myron Cory Drive, Hickman, KY 42050.

Saturday early voting will be taking place at the Fulton County Fire & Rescue Bldg, located at 7 State Route 94 E, Fulton, KY 42041.

Primary & General Election In-Person Location Plan

Fulton County plans to utilize 3 super center locations for the Primary & General Election Day process. Location 1 will be at the Fulton County Office Building, large bay area, it will be primarily used for 3 precincts. But will have the capability to service any voter in the County.

Location 2 will be at the Fulton County Fire & Rescue Building. This mini center will primarily be for 2 precincts but will have the capability to service any voter in the County.

Location 3 will be at the Fulton Independent High School Gymnasium. This location will primarily be used for 3 precincts with the capability to service any voter in the County.

Fulton County plans to set up early voting in the following locations and at the following times

Thursday	10:00-6:00	Fulton Pontotoc Building as a vote center
Friday	10:00-6:00	Fulton County Office Building as a vote center
Saturday	10:00-6:00	Fulton County Fire & Rescue Bldg as a vote center
