Grayson County 2026 Primary Election Plan

Our plan is to have 7 vote centers. Our 3 day no excuse early voting location will be held at The Center on Main located at 425 S. Main St. Leitchfield, Ky 42754 on Thursday May 14th, Friday May 15th, and Saturday May 16th, from 8:00 a.m. – 4:00 p.m. This location is a central location in the largest city in the county. The building is equipped with 24 hour video surveillance and will remain locked up while not in use.

The Excused In-Person absentee voting will take place in the Grayson County Clerks Office located at 125 A East Market St. Leitchfield, Ky 42754. Voting will be held on May 6, 7, 8, and May 11, 12, 13, 2026 from 8:00 a.m. – 4:00 p.m.

Our drop box location is in the Grayson County Clerks office located at 125 A East Marker St. Leitchfield, Ky 42754. There is cameras in place to monitor this area.
