The Harlan County Election Board has unanimously voted to continue using the voting center model for the 2026 Primary Election. Since its introduction during the 2023 primary, this model has proven highly effective and beneficial to our community. In 2024, we updated our voting center locations to better meet voters' needs. With these adjustments, we now have 21 voting centers positioned to serve citizens entering or leaving Harlan at both ends of the county, as well as sites distributed throughout the area, giving voters more convenient opportunities to cast their ballots.

Excused Absentee Voting will be held at the Harlan County Courthouse, 210 E Central Street, Ste 205, Harlan, KY 40831, on May 6, 7, 8, 11, 12, and 13, from 8:30 AM to 4:30 PM.

No-Excuse Absentee Voting will be held at the Harlan Civic Center, 201 S Main Street, Harlan, KY 40831, on May 14, 15, and 16, 2026, from 8:30 AM to 4:30 PM. This location is centrally located and very accessible for our voters.

The ballot drop box will be located inside the Harlan County Courthouse, 210 E Central Street, Ste 205, Harlan, KY 40831. This convenient location has served voters well in past elections and is easy to locate.

We are so happy to continue providing a voting model that not only works well but truly supports the needs and voices of Harlan County.
