

**MAY 19, 2026, PRIMARY ELECTION**  
**NARRATIVE EXPLANATION OF PERRY COUNTY PLAN**

Perry County's Election Plan will remain the same as November 5, 2024, General Election, except for two changes. Perry County will add an additional (3) Day Early Voting polling location. Also, we want to take Old Sears Building off as a County Wide Voting Center and add the Perry County Library. Perry County has 18,492 registered voters. The Perry County Board of Elections and I believe that to serve the voters of Perry County appropriately, we will need (21) polling locations for the Primary Election on May 19, 2026. We have attached a list of those (21) polling locations and the precincts that will be consolidated. Also, we have documented the approximate radius miles of travel for the voter to each voting center. Two maps have been created to pinpoint the location of our voting centers. One map will show the polling locations in the City of Hazard and the other map will show the polling locations in Perry County.

We are requesting (4) County Wide Voting Centers for the May 19, 2026, Primary Election. The County Wide Voting Centers will be located at the Perry County Central High School, Whitaker Athletic Center, Gospel Light Baptist Youth and Community Center and the Perry County Library. The Perry County Courthouse will be our polling location for (3) Day Early Voting and (6) Day In-person Absentee Voting. The Perry County Library will be the second polling location for the (3) Day Early Voting. In addition, Perry County will add Gospel Light Baptist Youth and Community Center as a third Early Voting polling location. Gospel Light Baptist Youth and Community Center will be open on Saturday, May 16, 2026, from 8:00 AM to 4:00 PM only.


