**Ballot Drop Box Location:** Rockcastle County Courthouse 205 East Main Street, Mt. Vernon, KY 40456 (US25 Entrance)

**6-Day Excused Early Voting:** Rockcastle County Courthouse 205 East Main Street, Mt. Vernon, KY 40456 (Clerk's Office)

**3-Day No Excuse In-Person Absentee Voting:** Rockcastle County Courthouse 205 East Main Street, Mt. Vernon, KY 40456 (3<sup>rd</sup> Floor-Conference Room), Thursday, May 14, 2026 (10AM-6PM), Friday, May 15, 2026 (6AM-2PM), and Saturday, May 16, 2026 (8AM-4PM).

**Election Day, May 19, 2026:** Rockcastle County will have 5 Voting Centers, meaning ALL precinct ballots will be available at each location, on Election Day from 6AM-6PM. Rockcastle County voters may use whichever location is most convenient for them.
