Per your request, Trigg County plans to go with the same plan as the 2024 Primary:

- All locations will have print on-demand ballots, with printed backup ballots available.
- There will be 2 Clerks, 2 Ballot Judges, 1 Judge, and 1 Sheriff at the following locations.
 - East Golden Pond Fire Department
 - Trigg County Emergency Operations Center
 - The Way Youth Center
- The other locations will have 1 Clerk, 1 Ballot Judge, 1 judge, and 1 Sheriff.
- All precinct officers will have an equal number of Democrat and Republican Officers

The location of the Drop Box will be in our office at 38 Main Street, Cadiz, KY.

The location for Excused Early Voting will be held at the Trigg County Clerk's office, from 8 am to 4 pm, Monday through Friday.

On Election Day on May 19, 2026, voters may vote at any one of the following locations of their choice:
