VOTING PLAN FOR BOYLE COUNTY 2023 PRIMARY ELECTION

The Boyle County Board of Elections met to discuss the Election Plan for future elections for this County. Just like in the 2022 Elections the board has elected to keep the same 6 voting centers and locations.

DROP BOX LOCATIONS

Drop box one is located outside the courthouse by side door. Drop box two is located inside the front doors by court security station.

EXCUSED & NO EXCUSE EARLY VOTING

No excuse early voting will stay at the Inter County Energy Coop building just like in the 2022 General Election. Excused early voting will take place in the Boyle County Courthouse at the Clerks Office.

ELECTION DAY

There will be a total of six voting centers spaced geographically for the North, South, East, West and central areas of the County.

1. Perryville Baptist Church
2. Parksville Baptist Church
3. Junction City Baptist Church
4. First Christian Church
5. Inter County Coop
6. Boyle County Fire Dept, Station 1

On the maps, I have marked the six voting locations. VC1, VC2 and VC3 are in the County and VC4, VC5 and VC6 are in the city limits of Danville. VC2 and VC6 have been added as two additional voting centers for Election Day. VC6 was used last election as an early voting location and will be used again this election for both early and election day voting.

We have planned for approximately 14 precinct officers at each location including informational personnel to direct voters where to go.

Our County will continue to use Hart verity voting machines in this election.

Voters will be notified of the early voting center and election day voting center locations on facebook, newspaper.

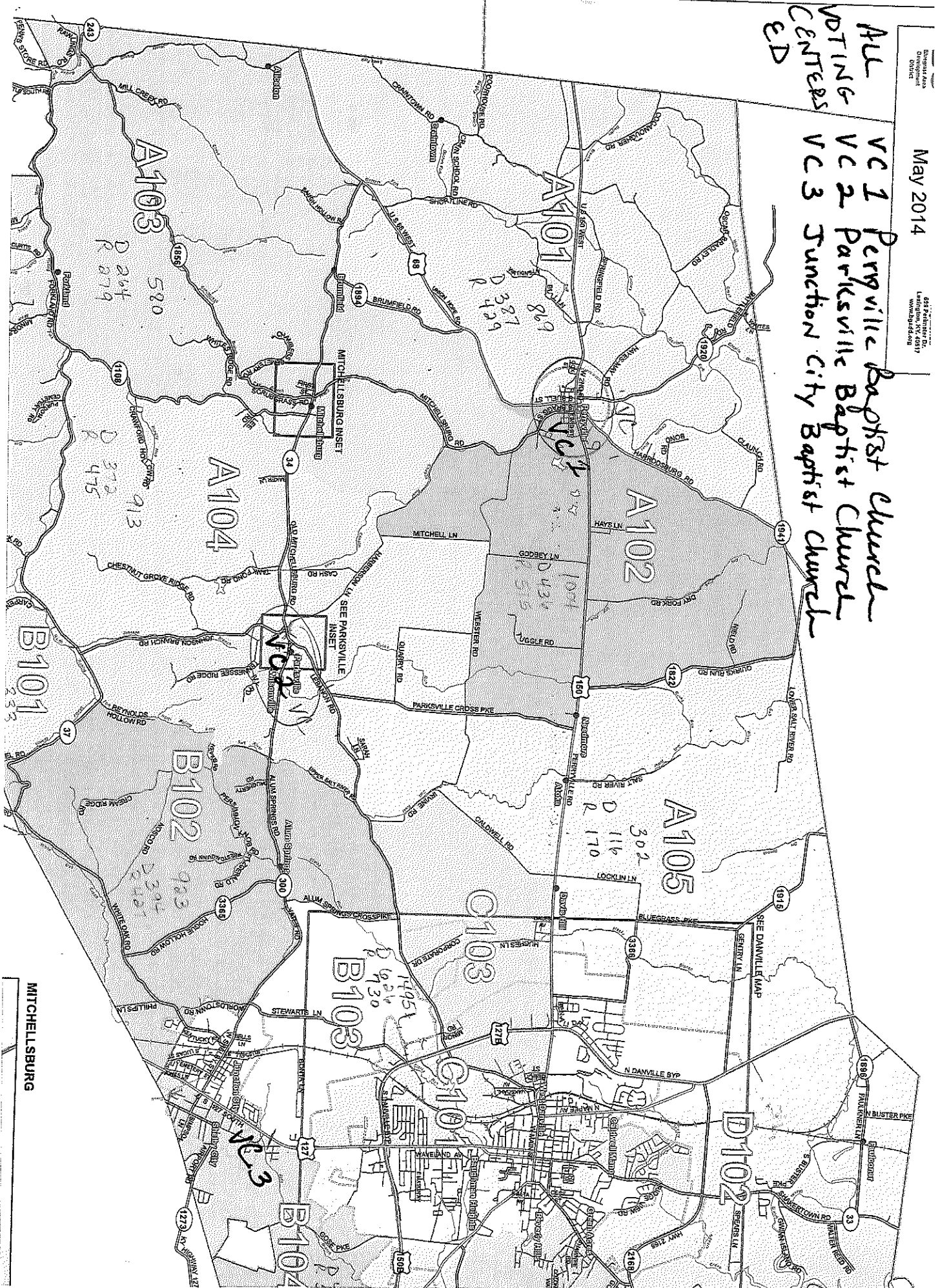

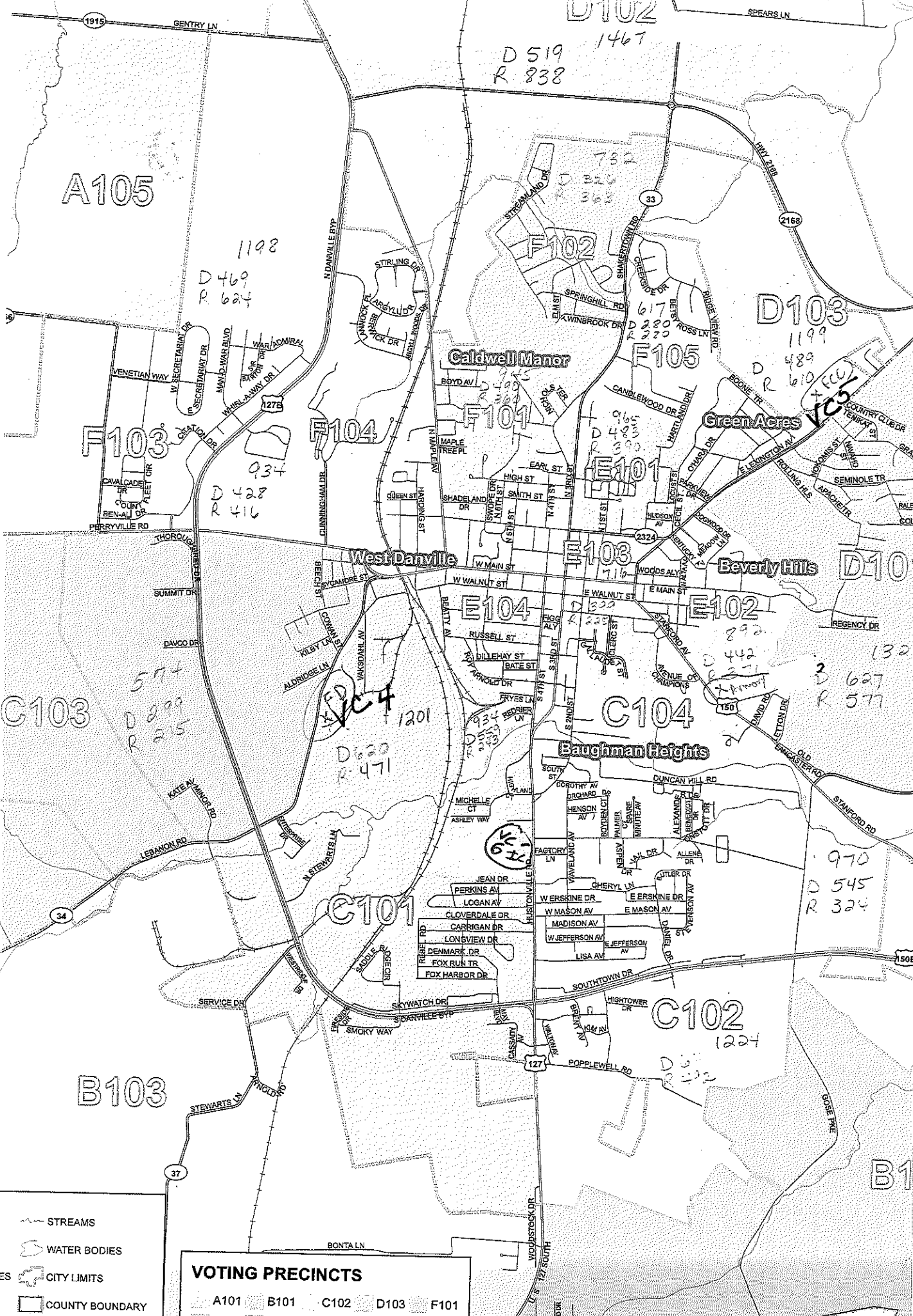
