VOTING PLAN FOR BOYLE COUNTY PRIMARY & GENERAL ELECTIONS 2022

The Boyle County Board of Elections met to discuss the Election Plan for future elections for this County. Due to the great success of the 2020 elections, the Board voted to approve a similar plan with a few additions. Two additional voting locations have been added for a total of 6 locations. All locations will be voting centers.

EARLY VOTING

Early voting will be at the National Guard Armory which can accommodate 50 or more voting booths at one time.

ELECTION DAY

There will be a total of six voting centers spaced geographically for the North, South, East, West and central areas of the County.

Perryville Baptist Church
Parksville Baptist Church
Junction City Baptist Church
First Christian Church
National Guard Armory
Boyle County Fire Department, Station 1

On the maps, I have marked the six voting locations. VC1, VC2 and VC3 are in the County and VC4, VC5 and VC6 are in the city limits of Danville. VC2 and VC6 have been added as two additional voting centers for Election Day. VC6 was used last election as an early voting location and will be used again this election for early voting and election day voting. EC6 is the largest voting center of the 6 locations.

We have planned for approximately 14 precinct officers at each location including informational personnel to direct voters where to go.

Our County has recently purchased the HART Verity voting machines and will implement them for the Primary Election.

Voters will be notified of the Early Voting Center and Election Day Voting Center locations on facebook and The Advocate Messenger newspaper.
