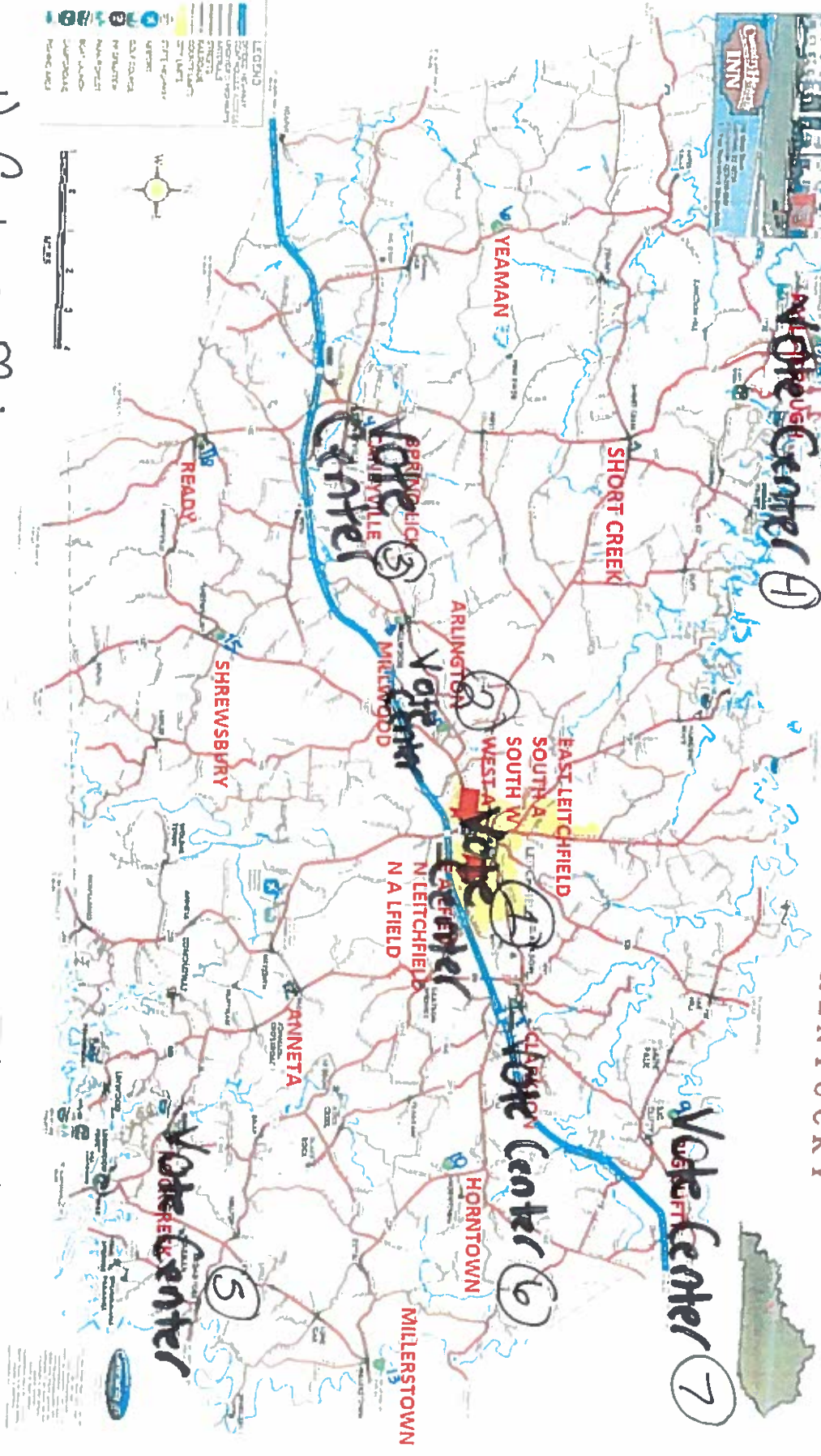
## Grayson County Primary 2023 Election Plan
