

Grayson County Primary 2022 Election Plan

Our plan is to open all precincts on Election Day. We will have one County Wide Vote Center at The Center on Main located at 425 S Main St. Leitchfield. We will offer early voting on Thursday May 12th, and Friday May 13th from 8:00 a.m. -4:30 p.m. and on Saturday May 14th from 8:00 a.m.-2:00 p.m. The building does have surveillance cameras in use. The machines will be locked up.

We have 4 precincts that vote at The Center on Main. They include A102 (South Leitchfield), C102(West A Leitchfield), E104(South A Leitchfield), and F101(Southwest Leitchfield).

We would like to consolidate B101 (Caneyville) and B102 (Spring Lick) precincts together as a Vote Center. These two precincts are already located at the same location, 202 E Maple St. Caneyville Ky 42721 which is the old Caneyville School.

We have 3 precincts voting at 726 John Hill Taylor Dr. Leitchfield Ky 42754 the Grayson Co. Middle School. They are A104 (East A Leitchfield, C103 (North Leitchfield) and D102 (North A Leitchfield). We would like to consolidate these 3 precincts to a Vote Center. This will help us on the number of workers and machines that we are having to use.

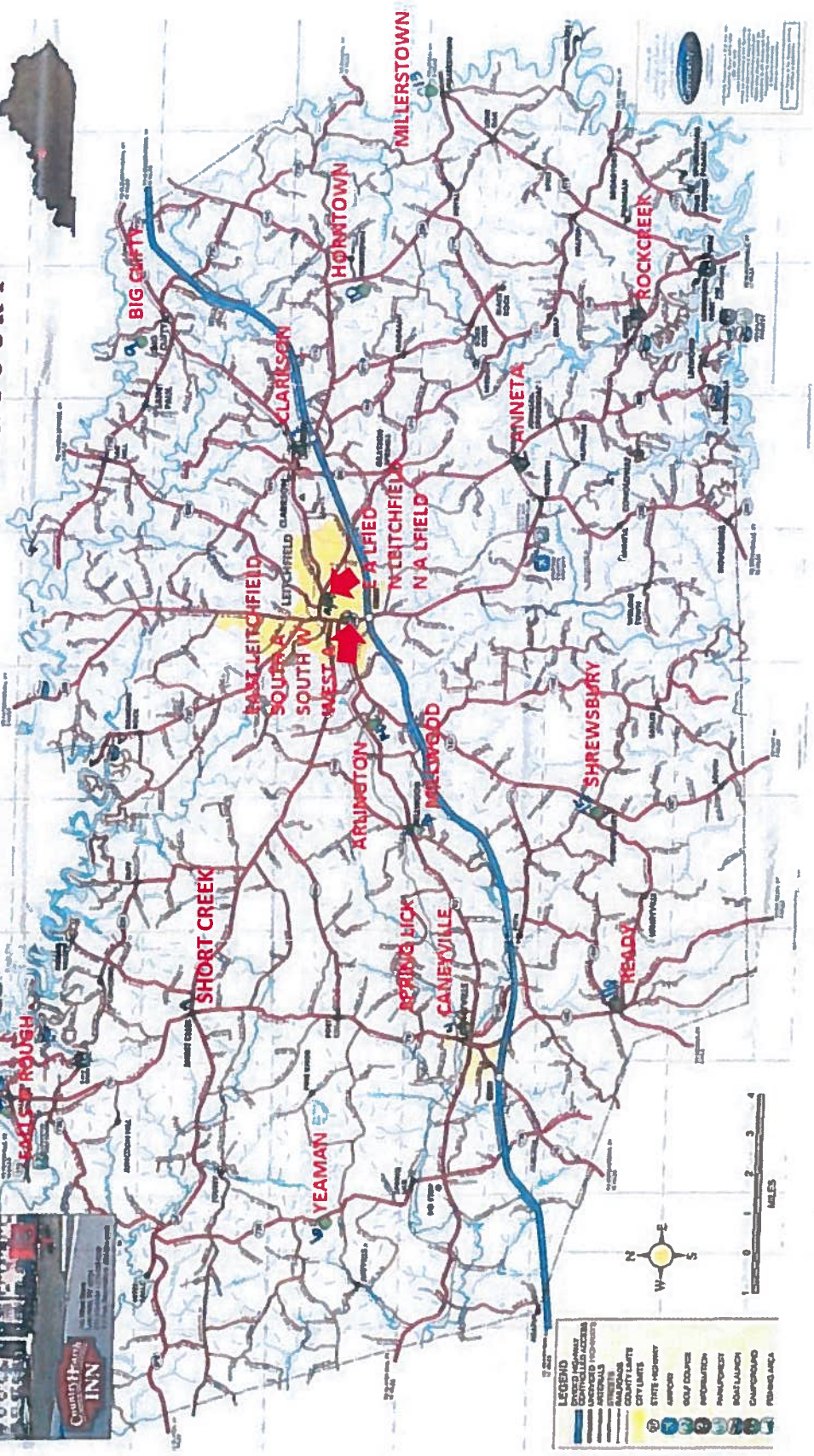
