After much thought and deliberation the Greenup County Board of Elections met and approved a plan for the Primary and General Election 2022, by unanimous vote on December 14, 2021. I have summarized our plan as follows and would be glad to answer questions that you may have about it.

We are very rural in some areas of our county, so the 6 precincts that we consider rural are going to be in the same locations that they have always been, except for last year. Those six precincts are Schultz-B105, Thompson-B107, Warnock-B110, East Fork-C102, Oldtown-C109, and Hunnewell-C110. We have checked addresses within these precincts and cannot justify moving them a greater distance from their polling location.

The other 10 locations and precincts are outlined on individual SBE74 forms and maps. These consolidated locations are where we are populated in Greenup County. Please see attached. These precincts will be using the same equipment and share election officers. It is my understanding that totals will be broken down for each precinct separately. We do plan on sending cards to notify our voters, as well as advertising in the newspaper and on websites to make the public aware of our changes. We will have one vote center at the Greenup County Courthouse. It will be staffed by precinct officers but the clerks office will be there for any additional ballots, forms, questions, etc that may arise.

Again, I would be glad to answer any questions that you may have for our plan. Any suggestions or improvements are welcomed.
