

JESSAMINE COUNTY CLERK'S OFFICE ELECTION PLAN

- WE WILL HAVE EIGHT LOCATIONS TO ACCOMMODATE ALL AREAS OF THE COUNTY
- 2. E-POLL CHECK-IN STATTIONS: DEPENDING ON THE SIZE OF THE FACILITY AND NORMAL TRAFFIC FLOW FOR THAT VOTING CENTER WE WILL HAVE 1-3 CHECK-IN STATIONS.
- **3.** VERITY PRINT: WE WILL HAVE 1 TO 2 VERITY PRINTS TO HAVE ON DEMAND PRINTING OF BALLOTS IN THE PRECINCT IF NECESSARY.
- **4.** VOTING BOOTHS: IN EACH LOCATION THERE WILL BE 6 12 VOTING BOOTHS FOR THE VOTERS TO MARK THEIR BALLOTS.
- **5.** BALLOT SCANNERS: AT EACH VOTING LOCATION THERE WILL BE 2-3 VERITY SCANS AND 1 VERITY ADA MACHINE.
- 6. PRECINCT OFFICERS: WE WILL HAVE 4 PRECINCT OFFICERS PER CHECK-IN STATIONS. WHICH WILL RESULT IN LESS OFFICERS BEING USED THAN WHEN WE HAD 36 PRECINCTS.
